### Locals clash with farmers in Delhi



Rharatiya Kisan Union (RKU) President Naresh Tikait addresses a mahananchayat at Muzaffarnagar, organised to mobilise support for the farmers' agitation against farm reform laws. A day after BKU leader Rakesh Tikait broke down at Ghazipur and tension spiralled amid fears that the farmers who had been camping there for two months would be forcibly removed, tens of thousands of farmers gathered in Muzaffarnagar on Friday. Naresh Tikait told the charged crowd to move towards the Delhi border at Ghazipur, about 100 km away. His emotive plea, captured by television cameras and other media, was widely circulated

PRESS TRUST OF INDIA New Delhi, 29 January

A group of people claiming to be locals clashed with protesting farmers at Delhi's Singhu border asking them to vacate the site as they had "insulted" the national flag on Republic Day.

Police fired tear gas and resorted to baton charge to break up the clash. The Delhi Police said Alipur SHO Pradeep Paliwal, attacked by a man with a sword during the clash, has suffered grievous injuries on his hand. The official said the man has been detained. Delhi's other border points also remained under heavy police deployment on Friday

Ratings agency ICRA said on Friday the agitations by farmers in the national capital region, Haryana, and Punjab will cause a ₹600-crore loss to toll collections. There is also a debt of over ₹9,300 crore taken by the stakeholders which is at "risk", ICRA said in the report.

# Minor blast near Israeli embassy, nobody hurt

New Delhi, 29 January

minor IED blast took place outside the Israeli embassy in the heart of Lutyens' Delhi on Friday, police said. The blast took place even as the Beating Retreat ceremony was going on at Rajpath, a few kilometres away.

Delhi Police Additional PRO Anil Mittal said initial impressions suggest that the blast, which took place near a pavement outside the embassy, could be an attempt to create a sensation. "A very low intensity improvised device went off at 5.05 pm. No injury to any person was reported, nor was there any damage to property except the glass panes of three vehicles parked nearby," Mittal said.

The Israeli foreign ministry said all its diplomats and embassy staff were "safe". Quoting an Israeli official, Reuters reported, "Israel is treating a small bomb blast near the Israeli embassy in New Delhi on Friday, which did not injure anyone, as a ter-

S Jaishankar spoke to Israeli Foreign Affairs Minister Gabi Ashkenazi. "We take this very Assured him seriously. (Ashkenazi) of the fullest protection for the embassy and Israeli diplomats. No effort will be spared to find the culprits," Jaishankar said.

After the incident, Home External Affairs Minister Minister Amit Shah has been Industrial Security Force, in touch with the Delhi Police top brass and is constantly monitoring the situation.

Footage of CCTV cameras installed nearby are being scanned to ascertain the sequence of events.

"Concerned by the news of a blast near Israeli embassy in Delhi. Agencies are determining the nature and cause of the blast. Thankfully, no loss of life reported yet. Any attempt to disturb the peace of Delhi should be firmly dealt with," Delhi Chief Minister Arvind Kejriwal tweeted.

After the blast, the Central which guards vital installations in the nuclear and aerospace domain, civil airports, and central government buildings has put on alert all its units across the country, official sources said. It has asked its personnel to maintain a "high level of alert", they said.

Tata Steel, however, said the

At the time of announcement of SSAB's interest in Tata Steel Netherlands. analysts had suggested an enterprise value of \$2-\$2.5 billion for Ijmuiden. The transaction was expected to bring Tata Steel closer to its target debt to Ebitda (earnings before interest, taxes, depretiation and amortisation) ratio of 3x. Annualised debt to Ebitda for Tata Steel consolidated stood at 3.9x in Q2.

Tata Steel However, reassured that the company was committed to its deleveraging plan. "Currently, around two-thirds of the business of Tata Steel is based in India with best in class, highly cost-competitive assets and strong cash flows, and Tata Steel remains committed to undertake significant deleveraging in FY21 and beyond," the company said.

This is not the first time that discussions for a solution to European operations have collapsed. In 2018, Tata Steel had agreed to a 50:50 joint venture with Germany's Thyssenkrupp, but the European Commission did not approve it. High costs have caused Europe to be a challenging market, and since the 6.2-billion-pound Corus acquisition in 2007, Tata Steel has been reducing its exposure to the market.

In FY16, the geographic composition of Tata Steel was one-third India and two-thirds international, which was now reversed in favour of the profitable side. The government claimed it. along with the Reserve Bank of India (RBI), announced packages worth ₹29.87 trillion, which is about 15 per cent of India's GDP. #### A call to print more money

The Survey claimed that India's trajectory during the pandemic was unique, and argued that "the upturn in the economy while avoiding a second wave of infections makes India a sui generis case in strategic policymaking amidst a once-in-acentury pandemic.'

Taking aim at alternative theories for the limited number of deaths in India - such as, for example, greater population resistance - the Survey assigns complete responsibility for the relatively low population mortality in India during the pandemic to the draconian nature of the initial lockdown. Indeed, it also argues that not only did the "stringent lockdown saved lives", but it also "supported a V-shaped recovery across all the economic indicators.

The Survey further claims that "costs and opportunities" were weighed "strategically" before the first lockdown, and it presented some basic calculations to conclude that government management led to India having 3.7 million less cases than expected.

The Survey conducted a similar back-of-the-envelope exercise - using population density, global numbers, and demographic profiles – for the various states of the Union, concluding in this case that Kerala and Telangana had saved the most lives, while Maharashtra "has performed the worst in number of cases and deaths". The Survey also made the politically effective, though economically questionable, decision to compare the effectiveness of pandemic control in globalised Maharashtra

Arguing that the regulators' forbearance on bank loans was a strong call based on the experience following the financial crisis of 2008, for withdrawing that forbearance quickly. It also praises the relief packages, indicating that they were calibrated and used "Bayesian updating". It noted that there was no point in stimulating demand when supply was constrained during the lockdown, comparing it to "pushing the accelerator while the foot was firmly on the brake". The time for stimulus, however, according to the Survey, has clearly arrived. In fact, it demands "a sustained, productive programme of permanent stimulus directed towards public investment, in both human and physical capital".

Concerns about debt sustainability and credit ratings downgrade in the face of "permanent stimulus" are dismissed. Arguing that India's willingness and ability to pay its debt is evident through history and through the size of its foreign exchange reserves when compared to the tiny proportion of sovereign, foreigncurrency-denominated debt.

The Survey attacked global credit ratings of India's sovereign debt, currently one step above junk status, as not reflecting India's fundamentals, and being "noisy, opaque and biased". Government spending should therefore ignore not just the debt to GDP ratio, but also the threat of downgrades, argued the survey: "India's fiscal policy, therefore, must not remain beholden to a noisy/biased measure of India's fundamentals and should instead reflect Gurudev Rabindranath Thakur's sentiment of a mind Cipla Limited
