HEARING ON SAME-SEX MARRIAGE Notion of man, woman is not absolute, says SC

'Can keep personal laws out, all lawyers can address us on Special Marriage Act'



he Supreme Court on Tuesday made it clear that it will not go into the personal laws governing marriages while deciding the pleas seeking legal validation for same-sex marriages and asked the lawyers to advance arguments on the Special Marriage Act.

A five-judge constitution bench headed by Chief Justice D Y Chandrachud termed the issue involving the pleas "complex" and said the very notion of a man and a woman, as referred to in the Special Marriage Act, is not "an absolute based on genitals".

"It is not the question of what your genitals are. It is far more complex, that's the point. So, even when the Special Marriage Act says man and woman, the very notion of a man and a woman is not an absolute based on genitals," said the Bench, which also comprised justices Justices S K Kaul, S R Bhat, Hima Kohli and PS Narasimha.

On being pointed out the difficulties and ramifications for the Hindu Marriage Act and personal laws of various religious groups if the apex court were to hold same-sex marriages valid, the Bench said, "Then we can keep the personal laws out of the equation and all of you (lawyers) can address us on the Special Marriage Act (a religion neutral marriage law)." The Special Marriage Act. 1954 is a law that provides a legal framework for the marriage of people



belonging to different religions or castes. It governs a civil marriage where the state sanctions the marriage rather than the religion.

Solicitor General Tushar Mehta, appearing for the Centre, referred to the laws on transgenders and said there are several rights such as the right to choose partners, privacy right, right to choose sexual orientation, and any discrimination is criminally prosecutable.

"However, the conferment of sociolegal status of marriage cannot be done through judicial decisions. It cannot even be done by the legislature. The acceptance has to come from within the society," the top government law officer said.

He said the problem will arise when a person, who is a Hindu, wants to avail the right to marry within the same sex while remaining a Hindu.

"Hindus and Muslims and other communities will be affected and that is why the states should be heard," the law officer said. "We are not going into the personal laws and now you want us to get into it. Why? How can you ask us to decide it? We cannot be compelled to hear everything," the Bench said.

Then this will amount to "short circuiting" the issue and the Centre's stand is not to hear it all, Mehta said, to which the CJI responded: "We are taking a middle course. We don't have to decide everything to decide something." On being pointed out that even the religionneutral Special Marriage Act has the term 'man and a woman', the bench said it is not the question of "genitals" and the very notion of the special law having "man and woman" is not restricted to the genitals.

Mehta, however, insisted it is restricted to the genitals and added there were several laws which the court will be making redundant inadvertently if it chose to give legal backing to same-sex marriages. The law officer gave the example of the Code of Criminal Procedure (CrPC) and said a woman cannot be called for examination after a certain time and there could be a situation where a man savs that though he has the genitals of a male he is not a man.

Court to hear plea on independent probe into killing of Atiq next week

The Supreme Court on Tuesday agreed to hear on April 24 a plea seeking an independent probe into the killing of gangsterturned-politician Atiq Ahmad and his brother Ashraf in Uttar Pradesh's Prayagraj. The duo were shot dead at point-blank range by three men posing as journalists in the middle of a media interaction on Saturday night while police personnel were escorting them to a medical college in Prayagraj for a checkup. A bench headed by Chief Justice DY Chandrachud took note of the submissions of advocate Vishal Tiwari who mentioned the matter seeking urgent hearing. The plea has also sought an inquiry into the 183 encounters that have taken place in Uttar PTI Pradesh since 2017.

Centre, Guj govt may seek review of order on remission files

The Centre and the Gujarat government on Tuesday told the Supreme Court that they may file a plea seeking a review of its March 27 order asking them to be ready with original files on the grant of remission to the convicts in the Bilkis Bano case. A Bench of Justices K M Joseph and B V Nagarathna questioned the paroles granted to 11 convicts during their incarceration period and said the gravity of the offence could have been considered by the state. It said, "You cannot compare victim's case with standard section 302 cases. Like you cannot compare apples with oranges, similarly massacre cannot be compared with single murder. Crimes are generally committed against society and the community."

Aravalli Bachao filed a petition in the NGT in April 2022, alleging that stones were being cleaved off the Aravallis in 16 places in Gurgaon and Nuh despite a Supreme Court ban on mining

In 2002, the Supreme Court's banned mining in the Aravallis in Faridabad, Gurugram, and Mewat (Nuh) to restore the range's ecology.

The Supreme Court, again in an order in 2009, said all mining activities must be suspended till statutory provisions for restoration and reclamation were complied with. particularly in cases where pits or quarries had been abandoned.

Tejpal Yadav, an environmentalist in Mahendragarh district of Haryana and a petitioner in cases against stone crushing units, said the low conviction rate is worrying because illegal mining is a threat to the ecology and human life.

charges filed

The issue made national headlines in July last year when Deputy Superintendent of Police Surender Singh Bishnoi was crushed by a group of illegal miners fleeing in a truck.

A majority of the complaints (303) received by Haryana police related to illegal transportation of minerals, followed by 259 for stone mining and 20 for illegally mined stock.

The highest number of complaints were registered in Nuh district (58 per cent), followed by Faridabad (20 per cent) and Gurugram (12 per cent), showed the police data between January 1, 2017 and January 31, 2023.


